# The Constitutional Committee on the Revelation of the People's Aspirations (CCRPA) - Statement 1/04

- 1. Burma Lawyers' Council (BLC) is the organization that has been undertaking the publishing of constitutional journals, booklets, and lecturing at trainings. In addition the BLC has been holding workshops, conducting the education of the people by writing and airing the radio broadcasting articles and suggesting the constitutional drafting process consistently.
- 2. National League for Democracy Liberated Area (NLD-LA) is the organization carrying out the political implementing process of the NLD between the ethnic organizations and democratic ones based along the border. Also, the NLD-LA endeavours to engage all those people abroad who love democracy and the international community with the work done on the Border and inside Burma.
- 3. The State Peace and Development Council (SPDC) is going to adopt a constitution by the policies, limitations and restrictions that they laid down at their disposal without obtaining the aspiration of the people and discussing with professionals.
- 4. If the process of the SPDC's is successfully implemented, the constitution which will grant the exercising of the executive, legislative and judiciary of the country's sovereign power will be manifested. Consequently, this will expand the life of the military dictatorship and the military dictators may rule legitimately. If such a process happens not only will it be impossible to overcome the current general crisis but also the situation of the people will deteriorate greatly.
- 5. Every citizen of Burma who loves human rights and democracy and desires the return of liberty and justice has the responsibility to forbid this occurrence. To assist the people in the fulfilling of their responsibility the BLC and NLD (LA) formed jointly the "Constitutional Committee on the Revelation of the People's Aspirations" on 15.9.2004 with the following objectives:
  - (a) To promote the studying of the grassroots people inside and outside Burma about constitutional knowledge and to enhance the participation of these people in the drafting process of a future federal constitution.
  - (b) To create a situation under which the grassroots people, including all ethnic nationalities, have the opportunities for submitting their suggestions, exchanging and sharing their opinions then every step of the drafting process must be inclusive. In order to have this inclusive process all responsible people for the drafting constitution must take into account such submissions.
  - (c) To present the suggestions collected from the grassroots people and international community to the responsible political leaders, organizations and the people inside and outside Burma.
- (6) The Constitutional Committee on the Revelation of the People's Aspirations (CCRPA) has been formed in order to fulfil the above three objectives properly. The people who will undertake the duties in this committee are as follows:
